Robert Chevalier – Lives in Lakeview Estates Property Owner's Association. There is an issue with people confusing Lakeview Estates Home Owner Association & Lakeview Estates Property Owner Association, these are 2 separate entities, which is a big difference. Lakeview Estates Property Owner's Association is a 22-home occupied community. The roads included are Basket Lane, Dayne Dr & Mautsbaum Circle which are private roads. The Home Owner's Association is registered with Carbon County and he had to answer questions from the County, EPA, DEP, Philadelphia, Harrisburg, and Property Association that think it's a Home Owner's Association and it is not. The reason he needs to coordinate with the township is because his responsibilities are to make sure the roads are plowed, so that Towamensing Garbage trucks can safely go through the roads, and the watershed for swails on the road. Township addressed that if there are any problems with the roads, we will let you know.

He also needs to address some permit issues that were delayed because of Future Homes. It was listed as development of Future Homes and it is not. There were 6 or 7 different builders in there. We have had some zoning and permit issues because of this.

Mr. Chevalier wanted to know if Towamensing Township was invited to Beltzville State Park meeting. No one at Franklin could tell him and Township reply was yes, we were invited but are not attending. Guy commended the Park in bringing this up in February rather than June. Ben is a very active Park Manger and has a good character. The fact that they are closing the park has mitigated a huge amount of the problems we had. The problems are not just yours with people parking in your yard but it affects Park personnel, the Townships personnel, State Troopers. From what we heard Troopers wrote out 102 citations and cars were towed. We did tell Mr. Christman the best way is to eliminate the problem is for him to take everyone to Harrisburg.
