Parryville Garbage – John Kleintop read in the Times News newspaper that Parryville has an issue, their vendor’s contract ends at the end of December. They received no bids. John reached out to get more info. Parryville was uncertain on what they were going to do. There are a lot of variables with this situation. Solicitor Nanovic stated he believes that Towamensing can legally help them with garbage collection. Although the township might have an issue with the landfill and the contract we have with the landfill for Towamensing since it does not include the tonnage for Parryville. Solicitor Nanovic had thoughts that a new bid would have to go out for Parryville’s tonnage. He recommends calling Waste Management and discuss. Solicitor Nanovic also stated he would speak with Atty Fryklund about this. **Guy Seifert made a motion to have Solicitor Nanovic investigate the legality of this situation and what was discussed – John Kleintop 2nd – AIF – Motion Carried.** Guy Seifert stated the township would continue to discuss the operation end of it. He also

advised the garbage service is how the township keeps the taxes down and this would just expand that; it would help everyone.
