In the previous meeting the road master explained our procedure and what has been done. Supervisor Seifert ask her how the road was today and she responded that the road was fine. Supervisor Seifert also asked if the maintenance today was sufficient and she also stated it was fine. (note the Township experienced about an 1-1/2” snow fall this morning and the daily temp never got above 30 deg Fahrenheit). Ms. Stroup then stated that something needed to change and the Township needed to take better care of this road and it should have special treatment. She also stated that the road was not treated today which seems to be in conflict with her previous statement. The Roadmaster restated that he had personally treated her road that day as it is his route. She then stated that his statement was untrue and something needed to change. Supervisor Seifert thanked her for her input and informed her that this would be taken under advisement.
