#### **PUBLIC PARTICIPATION - 5 MINUTE LIMIT:**

Tanya Frey, Clearview Drive resident questioned when the road agreement maintenance expires on Clearview and she provided her deed. Guy Seifert informed the township has nothing to do with the deed. He also stated the township does not have a standing with the road maintenance, the township will not take equipment or trucks on the roads because they are not fit. Tanya also questioned how the dumpster got to be placed there and to see the agreement. Guy Seifert explained there was no agreement from the township. He advised the homeowners from Clearview and Kennetta should get together and have a discussion.

Robin Genewski, Kennetta Lane resident, garbage concern. Guy Seifert reiterated the same response he gave Tanya regarding the same situation.

Jeff Genewski, Kennetta Lane resident, questioned if there was another way to get trash removal in this township. Guy Seifert explained business aspect of having township trash removal. Also, the township rates are lower.

Frank Sestok, Summer Mtn. Road resident, stated he is not directly affected by the dumpster issue but he wanted to know if there was not signed legal documentation how did the dumpster get there. Guy Seifert advised the landowner of the private road requested a dumpster placed for the residents of that road to use.

There was discussion on what is the right of way and if the dumpster was placed on private property or not. Robin Genewski asked if the homeowners should get together and get a lawyer. Tanya Frey stated each development would have to file separately but could use the same attorney.

Gwen Keefer, Kennetta Lane resident, concerned about if the Gun Club stops them from using the dumpster. She asked if they could put their garbage on the side of the road by mailboxes, off Gun Club. There was discussion about the geography of this location and due to road traffic, location, and amount of garbage, it is not possible.

Guy Seifert stated, the roads are not fit for the garbage trucks to go down, right now there are dumpsters for the residents to use and trucks can reach those dumpsters and get them emptied, trash is getting taken care of for now.

David Severino presented his partake in the America 250 along with other groups for Carbon County. They are trying to organize a celebration on July 4, 2026 for the 250<sup>th</sup> Birthday of America and incorporate all the municipalities within. There are many different events to join. # **NEW BUSINESS:**

John Kleintop stated it is important that the public know that there is a chart of how the supervisors get paid in this municipality, it is based on residents. Towamensing Township is less than 5,000 residents, salary is \$1875 annually. They enacted an ordinance that is has raised to \$3145. That does not take effect on sitting supervisors. You must run for supervisor and if you are elected, this salary will take effect for that supervisor only.

John Kleintop made a motion to move forward with enacting the Act 94 of 2024, Supervisor Compensation Ordinance. – Scott Mosier 2<sup>nd</sup>. Guy Seifert is not in favor.

Guy Seifert touched base on the Palmerton Area Comprehensive Plan that was done 15 years ago. It includes Towamensing, Lower Towamensing, Palmerton and Bowmanstown. The does several different things for each municipality and gives a better voice when dealing with PennDOT etc. Dwight Eisenhauer (Chair for PC) and Guy Seifert (Supervisor) attended the first meeting in the beginning of the year. The township took the Plan and had our engineer scan it and it can be provided to our Planning board for comment and correction. The new meeting will be in April and we will take our notes to the group at the meeting for discussion. There was discussion about Carbon County working on a comprehensive plan and contacting the county planning office to see if there are any pending scheduled meeting on this matter. Guy Seifert advised to have other Supervisors to go through Plan and make comments as well. Guy Seifert tabled this for now until farther information is provided.

Township Auditors met on January 10, 2025 and provided the minutes that approved the salary presented for Roadmaster Scott Mosier of \$27.04. **Guy Seifert made motion to approve the Auditor minutes – John Kleintop 2<sup>nd</sup> – AIF – Motion Carried** 

Employee #2 issue. Guy Seifert made a motion to discharge employee #2 – John Kleintop 2<sup>nd</sup> – AIF – Motion Carried.

John Kleintop discussed the ballfields repairs/upgrades that need attention. He stated the steps from the upper parking lot to the fields need repair. He asked the Township Engineer, Greg Haas to look at them, advise and create a bid to put concrete steps in. Greg Haas stated he would look at this and get back to the supervisors. John Kleintop also mentioned there are some other items at the field that need to be replaced, swings and bleachers. There will be a meeting between the township and the recreation committee to see what improvements can be made that will be better for our youth.

#### **HISTORICAL COMMISSION:**

Don Bonett advised that the committee only has 7 positions for officers but they will accept Patricia Mann as an associate member. John Kleintop made a motion to approve Patricia Mann as a member of the Historical Commission – Scott Mosier 2<sup>nd</sup> – AIF – Motion Carried.

Don Bonett submitted the list of Historical Commission members. Guy Seifert made a motion to accept the list submitted – Scott Mosier  $2^{nd}$  – AIF – Motion Carried.

Don Bonett asked to have a cabinet (purchased by HC) to be placed in the meeting room, that they could use for historical artifacts. He stated he will research and bring ideas to next meeting.
