<u>Kevin Christman</u> – 250 Lakeside Dr, he asked supervisors if they were okay with the pictures of cars being double parked? That is a safety issue. Response: No, township is not and does not have authority about the traffic. You should be contacting the state police. He would like us to write a letter and contact commissioners and who ever we can. The township told you we do not have authority over a state park.
