Approval of the Minutes:	None.	Rick Mertz called for a motion to approve the February 12, 2018 meeting minutes. Dave Beers made a motion to approve the minutes, seconded by James Shafer. All in favor.
Public Participation: Roy Christman	Roy Christman attended the meeting to speak on two topics. As a member of the Historical Commission, the first topic was the historical naming of township roads. He presented a list, copies of which were available for the Commission, and asked the members to read the list and provide input if they have information on how roads got their names. He would like this input by the next PC meeting. Roy also asked whether it is township policy that any new roads will be private roads. Currently, the Supervisors have stated that this is so. Members would like to know whether there is an Ordinance or Resolution in effect which addresses this. The second topic addressed entrances/exits to subdivisions where the lots all front on a township road. He provided a sketch and proposed that frontage roads be used instead of singular driveways for each residence. Roy would like this discussed at the Zoning Workshop on March 16th.	None.
